1. Missing or invalid Product Codes (PG02 record)

- ✓ PA0 Product Code Qualifier
 - ✓ Examples:
 - ✓ USDA AMS Exempt UNSPC Number
 - √ FDA Product Qualifier FDP
- ✓ PE4 Product Code
 - ✓ Examples:
 - ✓ EPA HFC CAS Number
 - ✓ FDA Product Code



2. Incorrect or Missing Entity Information (PG19/PG20 record)

- ✓ Invalid State/ZIP combinations, missing addresses, or Foreign Consignee listed instead of US
- √ Tax ID Number not on file in ACE

3. Invalid or Missing Affirmations of Compliance (PG23 record)

- ✓FDA-
 - ✓ Food Facility Registration and Prior Notice Confirmation Numbers
 - ✓ Medical Device, Pharmaceutical ID numbers



4. Improper Use of Disclaim Codes

- ✓ Aug 8, 2025 <u>CSMS #65868872</u> EPA new flags
- √ Filing via paper in error

5. Incorrect HTS Classification

√HTS codes drive PGA applicability

6. Missing Required Documents

- √ Phytosanitary Certificates (APHIS)
- ✓ FDA Prior Notice not submitted
- ✓ EPA Notice of Arrival



7. Invalid Country Codes

- ✓ Burma vs. Myanmar
- ✓ Mismatched country of origin, production, or shipment

8. Incorrect Units of Measure (UOM)

- ✓ FDA Incorrect FDA Reporting Quantities (Base Quantity vs. Packaging Containers)
- ✓ APHIS CORE start with KG and then what?



9. Invalid PGA Program Codes

- ✓ HTS codes programmed to match PGA Program Code based on commodity
 - ✓ Examples:
 - ✓ HTS 8516.50.0000 (Microwave Ovens) and FDA Product Code COS
 - ✓ HTS 0806.10.6005 (Fresh Grapes) not AP0700 (Misc. Proc. Product, but AP0600 Fruits & Vegetables)



PGA Corrections – when can you file?

Post Arrival & Release

- Within 10 days of arrival
- FDA / FWS only if rejected

Pre-Arrival & Release

- Cargo Release resubmitted
- PGA Correction
- FDA not less than 5 days of arrival unless rejected
- FWS not less than 3 days of arrival unless rejected

PGA Error Dictionary – Introduction – Document Overview

The PGA Error dictionary is a work in progress. It is unique in that the same error messages can be generated when similar errors are encountered for different agencies and/or program codes. This is why the same error code appears several times in different rows of the chart.

For example, there are several entries for 'PJ5 MSNG OR INVLD ENTITY ROLE CODE PER PGA'. The different rows to describe the error are broken down by the PGA code and the several program codes in that column. The 'Description' for that row describes the reason for that error in the context of the PGA and the program. As more error descriptions are compiled, the data filter by PGA code should be more useful in sorting error conditions.

PLEASE NOTE: The ultimate source of the PGA information is the PGA Message Set chapter of the ACE CATAIR, and the Implementation Guides issued by the PGAs. All of these can be found at this link: https://www.cbp.gov/trade/automated/catair

What is the SPEC/PGA/PE/CA column?

SPEC refers to a reject for the basic PGA message set structure (it can be in any input transaction that includes PGA data: AE, SE, PE or CA). The PGA Message Set chapter would be the resource to investigate that further.

PGA refers to a reject for a specific PGA business rule (it can be in any input transaction that includes PGA data: AE, SE, PE or CA). Refer to the specific PGA Implementation (aka Supplemental) Guide for further information.

PE refers to if the reject is for the stand alone Prior Notice PE transaction. Refer to the Stand-alone filing for PGA data (PE/PX) chapter.

CA refers to a reject related to the PGA data corrections application. Refer to the PGA Data Corrections (CA/CC) chapter.
